16 **RESOLUTION # \_\_\_\_\_ OF 2025: Adoption Of 2026 Preliminary Budget, and Setting Of Public**  
17 **Hearing**

19 WHEREAS, the Town Budget Officer presented the 2026 Tentative Budget to the Town Clerk and the Town  
20 Board at the September 23rd Regular Town Board meeting, and  
21

22 WHEREAS, prior to the presentation of the Tentative Budget, there were three public sessions to conduct  
23 line-by-line budget review on 9/8, 9/10, 9/17; and  
24

25 WHEREAS, the Town Board discussed and considered the 2026 Tentative Budget on 9/23/25 in a regular  
26 meeting and 10/9 in a regular meeting and made no further changes to the tentative budget;  
27

28 NOW, THEREFORE, BE IT  
29

30 RESOLVED that the Town Board accepts the Preliminary Budget for 2026 as presented at the 10/9/2025  
31 regular meeting for the Ulysses Town Board, with a 3.13% increase in the tax levy and a 1.55% tax rate  
32 increase for Town residents outside the Village of Trumansburg, and a 0.9% levy increase and a 3.08% tax  
33 rate decrease for Village of Trumansburg residents, and be it

35 FURTHER RESOLVED that the Town Board hold a public hearing at 10 Elm Street, Trumansburg, NY, on  
36 Tuesday, October 28, 2025 at 7p.m. for the purpose of hearing public comments on the Town of Ulysses  
37 2026 Preliminary Budget.

42 **RESOLUTION # \_\_\_\_\_ OF 2025: Relevy of Delinquent Water Charges for Districts 3 and 4**

44 WHEREAS, Town Code Chapter 200-10(C)(2) provides for delinquent water bills, taxes, assessments,  
45 fees,rents, or other service charges of Water District 3 & 4 to be placed on the ensuing year's tax roll as a  
46 relevy; and

48 WHEREAS, Town Code Chapter 200-10(C)(2) defines delinquent as "a period of at least 60 calendar days  
49 asof October 1 of any year"; and

50 WHEREAS, customers were notified that they could make payments on delinquent amounts through  
51 Sept. 30,2025;

53 NOW, THEREFORE, BE IT

55 RESOLVED, that the Ulysses Town Board approves the re-levy of unpaid delinquent water charges in the  
56 amount of \$\_\_\_\_\_ to the 2026 Town and County Tax Roll; and be it

58 FURTHER RESOLVED, that a certified copy of this resolution along with a listing of the properties with  
59 relevied water charges will be sent to the Tompkins County Assessment Department for the purpose of  
60 adding these delinquent charges to the 2026 Town and County Tax Roll.

62 **RESOLUTION # \_\_\_\_\_ OF 2025: Creation of Cleaner Position for the Town**
