16 **RESOLUTION # _____ OF 2025: Adoption Of 2026 Preliminary Budget, and Setting Of Public**

19 WHEREAS, the Town Budget Officer presented the 2026 Tentative Budget to the Town Clerk and the Town
20 Board at the September 23rd Regular Town Board meeting, and
21

22 WHEREAS, prior to the presentation of the Tentative Budget, there were three public sessions to conduct
23 line-by-line budget review on 9/8, 9/10, 9/17; and

25 WHEREAS, the Town Board discussed and considered the 2026 Tentative Budget on 9/23/25 in a regular
26 meeting and 10/9 in a regular meeting and made no further changes to the tentative budget;

28 NOW, THEREFORE, BE IT

30 RESOLVED that the Town Board accepts the Preliminary Budget for 2026 as presented at the 10/9/2025
31 regular meeting for the Ulysses Town Board, with a 3.13% increase in the tax levy and a 1.55% tax rate
32 increase for Town residents outside the Village of Trumansburg, and a 0.9% levy increase and a 3.08% tax
33 rate decrease for Village of Trumansburg residents, and be it

35 FURTHER RESOLVED that the Town Board hold a public hearing at 10 Elm Street, Trumansburg, NY, on
36 Tuesday, October 28, 2025 at 7p.m. for the purpose of hearing public comments on the Town of Ulysses
37 2026 Preliminary Budget.

46 **RESOLUTION # _____ OF 2025: Relevy of Delinquent Water Charges for Districts 3 and 4**

48 WHEREAS, Town Code Chapter 200-10(C)(2) provides for delinquent water bills, taxes, assessments,
49 fees, rents, or other service charges of Water District 3 & 4 to be placed on the ensuing year's tax roll as a
50 relevy; and

52 WHEREAS, Town Code Chapter 200-10(C)(2) defines delinquent as "a period of at least 60 calendar days
53 as of October 1 of any year"; and

54 WHEREAS, customers were notified that they could make payments on delinquent amounts through
55 Sept. 30,2025;

57 NOW, THEREFORE, BE IT

59 RESOLVED, that the Ulysses Town Board approves the re-levy of unpaid delinquent water charges in the
60 amount of \$6522.14 to the 2026 Town and County Tax Roll; and be it

62 FURTHER RESOLVED, that a certified copy of this resolution along with a listing of the properties with
63 relevied water charges will be sent to the Tompkins County Assessment Department for the purpose of
64 adding these delinquent charges to the 2026 Town and County Tax Roll.

66 **RESOLUTION # _____ OF 2025: Creation of Cleaner Position for the Town**

68 WHEREAS, the Town of Ulysses currently utilizes an outside contractor to perform cleaning services at
69 the Town Hall, and

70 WHEREAS, obtaining competitive vendor quotes from time to time is a best practice; and

71 WHEREAS, it has been difficult to obtain multiple acceptable vendor quotes for cleaning services due to
72 prevailing wage requirements for contractors; and

73 WHEREAS, after internal conversations, it has been determined that it will be better to employ someone
74 rather than seek competitive quotes for the cleaning contract at this time; and

75 WHEREAS, the Town Board must establish a position and pay rate to hire a Cleaner; and

76 WERREAS, it has been determined that the estimated total cost of such a position will not exceed the
77 funds available for contracted cleaning services;

78 NOW THEREFORE BE IT RESOLVED that the Ulysses Town Board approves the position of Cleaner as
79 listed in Tompkins County Personnel job descriptions; and be it

80 FURTHER RESOLVED that the pay rate will be approved at \$22 per hour in the 2025 budget; and be it

81 FURTHER RESOLVED that the pay rate would increase by 3% in the 2026 budget.
