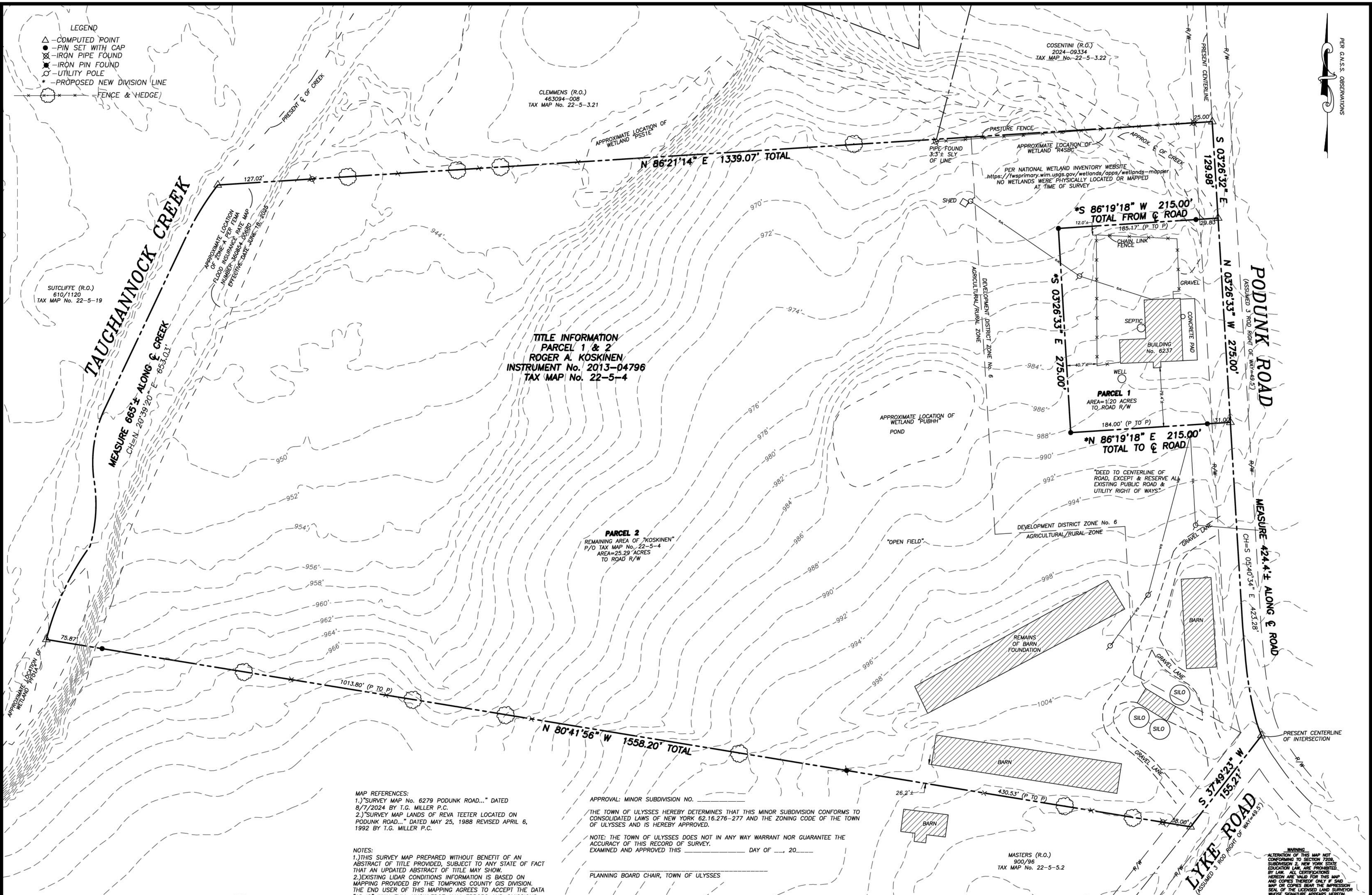

THIS INDENTURE, made the 9th day of April in the year 2013

BETWEEN Stanley R. Koskinen, of 4248 Waterburg Road, Town of Ulysses, holder of an interest in 12/13 of the property herein described, party of the first part, and Roger A. Koskinen, of 6256 Podunk Road, Town of Ulysses, party of the second part, holder of an interest in 1/13 of the property herein described and tenant in common with the grantor,

WITNESSETH, that the party of the first part, in consideration of One Dollar paid by the party of the second part, does hereby remise, release and quitclaim unto the party of the second part, the heirs or successors and assigns of the party of the second part forever, all of his rights, title, interest, and possession of the property bounded and described as follows:

ALL that certain plot, piece or parcel of land, with the buildings and improvements thereon erected, situate, lying and being in the Town of Ulysses, County of Tompkins, State Of New York, on Military Lot #12 in said Town of Ulysses, more particularly bounded and described as follows:

BEGINNING on the center of the highway running from Podunk Road toward Waterburg (Podunk Road - County Route 146) about 31.5 chains north of the south line of said Military Lot #12; running thence southerly along the centerline of said highway about 13 chains to a fork in the road; thence southwesterly along the centerline of the highway (Lyke Road) about 2.25 chains; thence northwesterly along the northerly line of lands now or formerly of William Hill (earlier of Eugene Terry) about 24 chains to Taughannock Creek; thence northerly along Taughannock Creek about 12 chains; thence easterly along the south line of lands now or formerly of John Johnson about 19 chains to the point or place of beginning, containing about 28.7 acres of land, more or less.





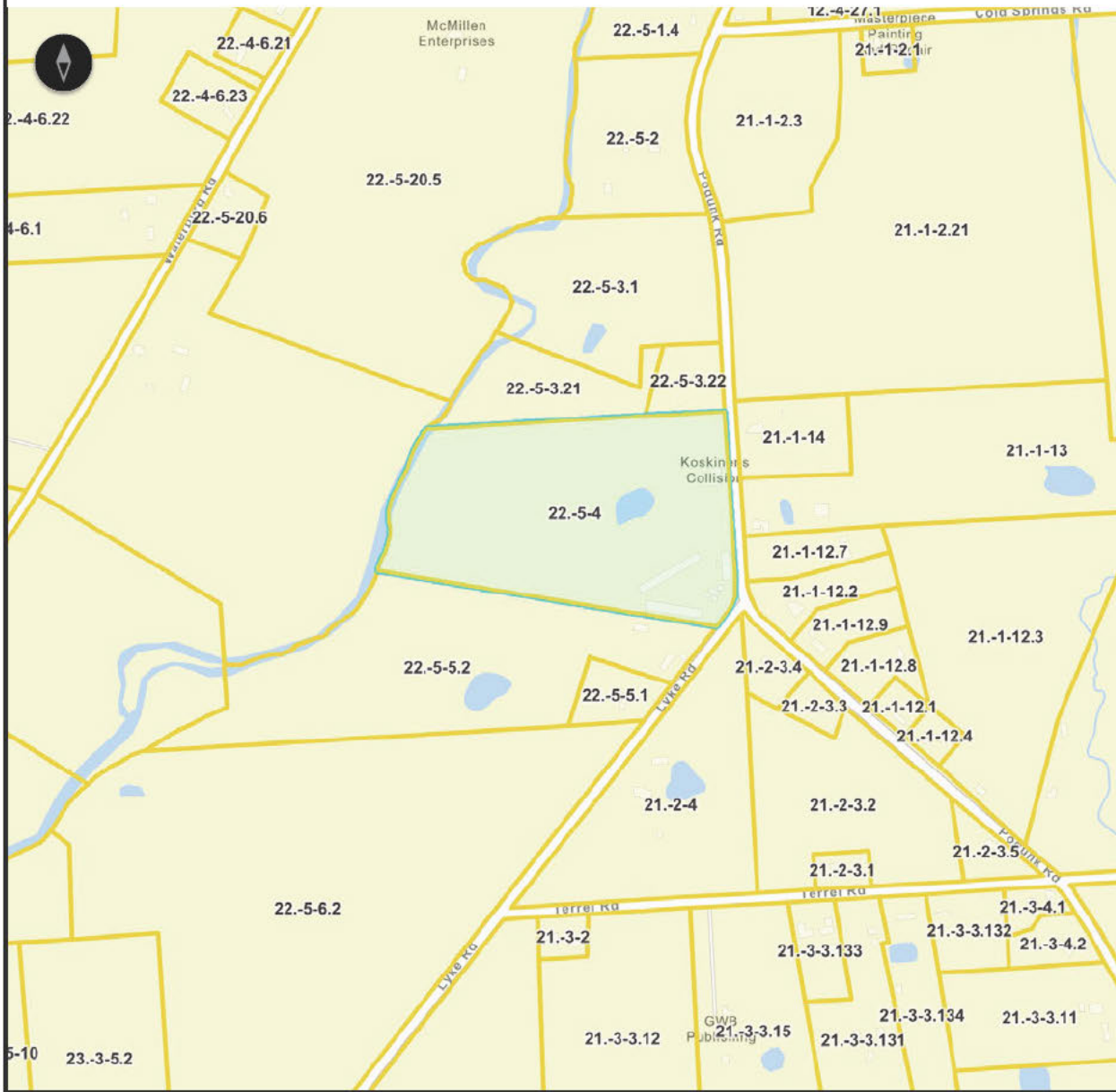
