SPR2506-01: Balakrishnan Menon, Renovation and Addition to Existing Dwelling Unit,

Final Site Plan Review

99 Maplewood Road, Parcel Number 29.-1-1

The applicant, Christina Gonzalez, on behalf of the property owners, Jeetu & Purnima Balakrishnan, proposes a renovation and addition of a second floor to an existing detached dwelling unit. Per the Code of the Town of Ulysses (CTU) 212-43.A, 'single-family residences' and their accessory structures are permitted in the LS zone but require site plan review by the Planning Board when located in a steep slope or unique natural area (UNA).

Ryan James from Brotherton Construction spoke about stormwater on the site and existing vegetation. James stated that standard measures will be taken during construction to reduce impact.

The Board reviewed photos of the existing gutters.

A. SPR2507-01: Culler Chase, Renovation and Addition to Existing Accessory Structure, Sketch Plan Review

123 Maplewood Road, Parcel Number 28.-1-17

The applicant, Ryan James, on behalf of the property owners, Jonathan Culler & Cynthia Chase, proposes a renovation and addition to an existing detached accessory building. Per the Code of the Town of Ulysses (CTU) 212-44, 'accessory buildings' are permitted in the LS zone but require site plan review by the Planning Board when located in a steep slope or unique natural area (UNA).

James described the proposed renovations for the 3-season structure. An incinerator toilet is planned to be added. A variance application has been made for the setbacks.

The Board discussed drainage on the site and improvements to the stairs, which are partially in the right-of-way.
