Old Business Items

SPR2507-02: Wilson Tram Final Site Plan Review

1587 Taughannock Blvd, Parcel Number 18.-1-1.4

The applicant, Shawn Ritchie, on behalf of the owner, Victoria Wilson, proposes to construct a new 85' tram system from the upper portion of the subject lot down the steep slope to the lower portion of the lot near the shoreline. The Planning Board previously reviewed the sketch plan proposal on August 19, 2025 and scheduled final site plan review for the September 16th meeting.

Mr. Klankowski asked if any comments were received. Mr. Tygesen responded in the negative and added that the BZA has a scheduled hearing for tomorrow for the related variances.
